

### **POLICE**

- One of the fundamental bodies
  - → cooperation is necessary and unavoidable
- Organisation and Work of the Police Act, 2013
  - → Chapter 5 Article 35 Partnership cooperation to ensure

greater security

An important part of the national security system





### COMMUNITY ORIENTED POLICING

"The police focus their activities on preventing undesirable occurrences, preventing risk factors, managing risk groups, and ensuring the overall safety of the community."

The main objective → increased safety

# CRIME PREVENTION IN LOCAL COMMUNITIES

- Preventive action must be based on studies and knowledge
  - → effective and professionally efficient interventions
- Addressing cause-and-effect relationship
- Supporting organizational and financial structures
  - → implementing prevention in the long term



# ASSESSING THE EFFECTIVENESS OF POLICE - COMMUNITY RELATIONS

Measuring the success of community policing implementation in Slovenia

(Lobnikar, Prislan & Modic, 2016)

#### Measuring instrument with 4 areas:

- Quality of police contact with residents
- Level of detection of criminal behavior in the environment
- Perception of safety
- Level of community cohesion among residents

#### **RESULTS:**

- o Accumulation of rubbish and worthless goods
- not impartial
  - Residents feel safe
