## **INTRODUCTION**


- A modern approach to gathering information on criminal movements and developments
- Detection of planned attacks, smuggling of drugs and weapons, money laundering, and other activities of organized crime
- <u>The primary goal-preservation the integrity of the personal and public safety of citizens</u>
- <u>Focus-prevention of the commission of a specific criminal act</u>

Edward Snowden is an American former computer intelligence consultant who leaked highly classified information from the NSA, when he was employee.





Julian Paul Assange –publisher and scypher punk activist. He founded WikiLeaks in 2006. Ecuador granted him political asylum in 2012. After seven years he was arrested as a consequence of his asylum being revoked and his citizenship taken away.

-OCD, at the request of the operational units, performs checks and by actively participating in operational processing provides support to these units for the realization of ongoing cases.
