The MSU Faculty of Law is most delighted to have a long and stable cooperation with FCJS-UM. This exchange has proved to be fruitful and mutually beneficial.

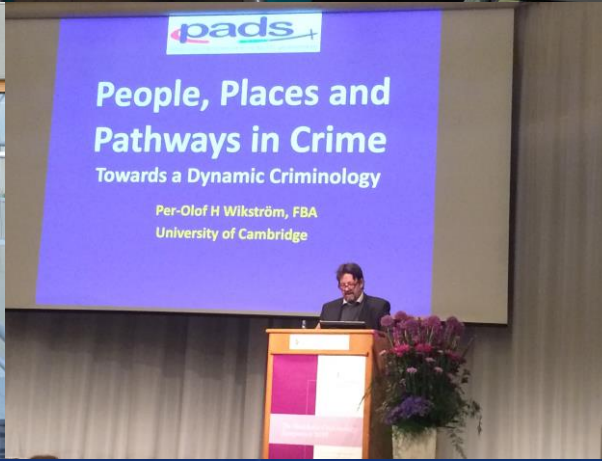
